

### Investment Objective

The World Stars Global Equity Fund seeks to achieve its objective by investing in a concentrated selection of shares in leading global companies with enduring competitive advantages and a long runway of growth.

We select companies based on our own fundamental research, taking a long-term horizon. We do not follow benchmarks and always seek to invest in quality and value.

Quality means companies that are global leaders, have strong competitive positions and pricing power in structurally attractive and growing markets, have management teams with strong records of value creation and have robust balance sheets.

Value means buying those companies at prices that allow for the prospect of significant capital growth over 5-10 years or more.

### Portfolio Comment

Our World Stars Global Equity fund rose strongly led by robust Q3 results across our companies. Of the 23 which have now reported for Q3, 19 have maintained or raised their full year earnings guidance with a small reduction from the other four. Performance was led by our digital stocks which accounted for five of the top ten performers.


There was limited change in the macro background. In the US core CPI rose slightly to 3.0% even with the impact of tariffs. The US Fed cut rates by 25bps to 3.75% following 25bps in September, driven primarily by the labour market, and the US Government continued to work on refining the new tariff arrangements, including with China.

Our portfolio has a significant exposure to AI, both to the enablers of the AI revolution such as *Nvidia* (+8%) and *Amphenol* (+13%), and to companies which are generating substantial incremental and high margin revenues from the injection of AI. This group includes *Alphabet* (+16%) which is delivering faster growth across Search, YouTube and Google Cloud from AI. Its Gemini AI app now has 650m monthly active users vs. 350m in March 2025. Similarly, *Amazon*'s (+11%) revenue growth has accelerated across ecommerce, digital advertising and cloud services (AWS) from the injection of AI.

*LVMH*'s (+18%) Q3 revenues improved, particularly in Fashion & Leather Goods, with signs of a recovery in demand for luxury goods and with a significant boost from 'self-help' initiatives.





## Geographic Exposure by Listing


