ITEM 1: INTRODUCTION

J. Stern & Co LLP (“Stern,” the “Firm,” “we,” “us”) is registered with the U.S. Securities and Exchange Commission as an Investment Advisor. It is important for you, as a retail investor, to understand that the services and fees of investment advisers are different than the services provided, and fees charged by a broker-dealer. Free and simple tools are available to research firms and financial professionals at www.Investor.gov/CRS, which also provides educational materials about investment advisers, and investing.

ITEM 2: RELATIONSHIPS AND SERVICES

What investment services and advice can you provide me, what's the process?

Our focus is discretionary investment management, running a small number of differentiated investment strategies including our World Stars Global Equity Strategy, a Multi-Asset Income Strategy and our Emerging Market Corporate Debt Stars Strategy.

We offer investors access to these strategies either via a single managed account (or “SMA”) or via an investment fund (a “Fund”) for those investors eligible and able to invest in funds established in Luxembourg. SMAs, on a discretionary basis, are available to all clients, but our UK FCA authorisation prevents us from giving investment advice to retail clients. Our investment decisions with respect to each strategy and managed portfolios are subject to investment objectives, strategies, policies and restrictions. These are set out in the client agreements or the relevant prospectus or offering document for each fund (the “Offering Document”).

Our World Stars Global Equity is available via SMAs or, for those that are eligible, via the Luxembourg established Alpha UCITS SICAV J. Stern & Co. World Stars Global Equity Fund. The Multi-Asset Income strategy is targeted at clients who are seeking primarily income and is available in SMAs or via our Luxembourg established Star Multi-Asset Income Fund. The Emerging Market Corporate Debt strategy is available in SMAs. We are working currently to establish a fund based in Luxembourg that follows the same strategy. You must meet certain account minimums and other criteria to participate in our management services. These minimums and criteria vary depending on the service and are disclosed in Part 2A of our Form ADV. We are required to monitor your portfolio, investment strategy and investments on an on ongoing basis. We will contact you when we become aware of a significant change in the market or to your individual circumstances.

ITEM 3: FEES, COSTS, CONFLICTS, AND STANDARD OF CONDUCT

What fees will I pay?

The fees that we charge clients for SMA are set out in the corresponding client agreement and are based on the asset value of clients’ assets. Custodians will charge separately. The standard fee ranges from 0.70% p.a. (for charities) to our standard 1.00% p.a. (excluding any value added tax) but are negotiable and other fee structures (including performance fees) are available.

The fees for Funds range from 0.65% (for charities) to 0.90% for investments of \$1m or more and 1.2% for investors who cannot invest as much as \$5m into a SMA. The Funds incur additional costs and charges which we seek to limit to 0.30%. More details are contained in the relevant Fund offering memorandums.

What are your legal obligations to me when acting as my investment advisor? How else does your firm make money and what conflicts of interest do you have?

When we act as your investment adviser, we have to act in your best interest and not put our interests ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide to you.

Example: An employee may be offered or provided gifts, entertainment or other forms of corporate hospitality which could create an incentive for the employee to act in a manner which is not in your best interest. There can also be conflicts arising out of personal trading by employees in the same securities in which your account invests.

How do your financial professionals make money?

All Stern staff are paid via salary, discretionary bonuses and retirement benefits. Factors considered when assessing the discretionary bonus element would include performance, appraisals, client service, compliance, developing new areas of the business and collaboration. For those partners who have a share of the equity in the J. Stern & Co Group, profits are divided up through a points system which is a weighted rating in favor of effective risk and compliance with the Firm's policies and procedures.
